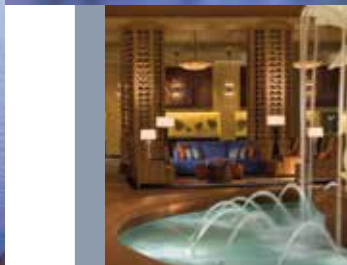
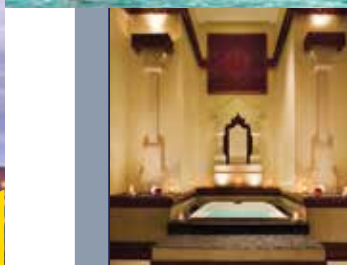

Course Description & Objectives
